# From the Annual Meeting . . .

At the annual meeting, we discussed the possibility of adding a clause to our C&R's to require new purchasers to occupy the home for two years before using the property as a rental. One of the main concerns we heard from attendees was new owners having unique or special circumstances that would not allow them to meet that restriction. Our attorney advised that the language of the rule would allow for an HOA Board review if a circumstance of that nature arises.

The majority of respondents were in favor such a rule, so we will be working with our attorney this calendar year to see how & when it could be implemented. As of now, please know that there is no rule or change in place, & new homeowners or sellers are not required to follow or restrict themselves to that proposal. We were only discussing the idea at the meeting in order to gauge homeowners' interest levels.

# A New Look for Older Homes

Reyhani unit homeowners recently received a flyer discussing the new garage door color for their homes. To give our older units a bit of a facelift, after color testing 10 colors, the board chose Benjamin Moore "Chelsea Gray" in a flat finish to match the flat finish of the current "Seagull Gray". The "Chelsea Gray" offers a bit of contrast & a contemporary look that is seen in more modern developments with similar style units.

The new color, Benjamin Moore "Chelsea Gray", can continue to be purchased at Duval Paint or can now be purchased at ACE Hardware in Neptune Beach. ACE is an authorized Benjamin Moore dealer & offers a wider variety of paint grades for homeowners, while Duval Paint focuses more on commercial grades. The test units were painted using the "Ben" line of paint; however, a higher grade is also available at ACE if you'd like to use it instead. (Don't forget: you can use your coupons at ACE to save on your paint costs!)

All Reyhani units must have their garage doors painted by June 10<sup>th</sup>, 2018. This gives homeowners almost a full 3 months to complete the work.
