Rule #25 - Window colors (addition of white option) for Reyhani Units

- The window color options are:

Should a homeowner not follow the HOA guidelines, the work must be replaced full expense to the owner.

Rule # 24, August 19, 2021 (Painting Coquina for Reyhani Units)

Rule #24 - Allowance of Painting Coquina for Reyhani Units

The Selva Lakes Homeowners Association Board of Directors on August 19<sup>th</sup>, 2021 voted to adopt the following rule governing the ability of homeowners to paint the coquina on their units. It was determined and agreed upon that homeowners should be allowed to incorporate painting the coquina as an option to repair / upkeep their units.

- The coquina must have all cracks and imperfections repaired prior to painting.
- The appropriate prep should be adhered to prior to painting the coguina.
- The coquina must be painted using Benjamin Moore Seagull Gray.
- If painting is completed, it must be kept up for the life of the home to repair peeling, flaking, etc.
- It is HIGHLY recommended that a professional painter with experience painting coquina is employed.

Homeowners are required to fill out and submit an ARC form to the Architectural Review Committee) prior to the coquina being placed on the unit. No work can begin until the ARC approves the request. Should a homeowner not follow the HOA guidelines, the work must be replaced full expense to the owner.

Rule # 23, February 2021 (Gutters for Reyhani Units)

Rule #23 – Allowance of matched gray gutters for Reyhani Units

The Selva Lakes Homeowners Association Board of Directors on February 11<sup>th</sup>, 2021 voted to adopt the following rule governing the ability of homeowners to match gutter color as opposed to painting gutters. It was determined and agreed upon that homeowners should be allowed to use a gray gutter that matches the Benjamin Moore Seagull Gray on the Reyhani units instead of painting the gutters.

- The gutters must match the approved Seagull Gray.
- A "swatch" or "sample" needs to be submitted (or picture of same) with the ARC request against the homeowner residence.

Homeowners are required to fill out and submit an ARC form to the Architectural Review Committee) prior to the gutters being placed on the unit. No work can begin until the ARC approves the request. Should a homeowner not follow the HOA guidelines, the work must be replaced full expense to the owner.
