## 3) Materials and Landscaping

- e) Dead trees cut on mailbox islands. Still getting quotes in on what trees and ground cover to plant. Must be self-maintaining. Open to suggestions.

#### 4) Pool

- a) Lights around pool area replaced.
- b) Flooring in restroom replaced with non-slip materials.
- c) Broken umbrellas replaced.
- d) Countertop and sink replaced.
- e) Filtration pump replaced.
- f) Fixed gate so it is secure
- g) Need to locate restroom deadbolt key. Mary Kaye.
- h) For any residents who would like to have a party at the pool, the calendar is in the pool area so you can sign up. Only one party at a time and the pool area will remain open to residents during parties. There is a \$50 deposit required.

#### 5) Budget Review

- a) We moved to new accounting company in January. Now Lifestyles Management.
- b) Dues can be paid online or via mail. Concern that bills were arriving late but there is a 30-day grace period. Example: A bill received Dec 28<sup>th</sup> for Dec is not due until Jan 31. Gabe to check with Lifestyles on mailing dates.
- c) Reviewed 2022 and proposed budget for 2023.
- d) 2023 has several large one-time expenses expected for paving, common areas, fence repairs and lake erosion.

- e) Dues were \$33 per month in 1986. Currently, 36 years later, they are \$45 per month. Considering our operational cost increases (presented) as well as upcoming one-time expenses (also presented), a \$5.00 per month increase will begin in April of 2023 and an additional \$5.00 per month will begin in 2024.
- f) The perimeter fence will eventually need to be replaced in 5-7 years. This will be a large expense that will require a special assessment to all residents.
